PLANNING BOARD TRAFFIC ENGINEER

<u>GENERAL CRITERIA</u>: The Township of Pemberton desires to appoint a firm or firms to provide planning traffic engineering services to the Township. Applicant should demonstrate knowledge and experience with respect to all aspects of planning traffic engineering services required by a municipal entity. Any experience or knowledge of matters that directly affect the Township of Pemberton should be addressed.

MANDATORY MINIMUM REQUIREMENTS:
